21.8.20	2.1	<ul style="list-style-type: none"> <li>Anyone with symptoms must remain at home and self-isolate for 10 days from testing positive (rather than 7 days- due to extension of self-isolation period increase to 10 days)</li> </ul>
26.8.20	4.3	<ul style="list-style-type: none"> <li>Carry out a risk assessment (each trimester) for new and Expectant Mothers</li> </ul>
29.8.20	1.16	<ul style="list-style-type: none"> <li>In the event that a parent insists on a child attending school when a pupil has symptoms, the school to take the decision to refuse the child to protect their pupils and staff from possible infection with coronavirus (COVID-19). Any such decision would need to be carefully considered in light of all the circumstances and the current public health advice.</li> </ul>
29.8.20	1.12	<ul style="list-style-type: none"> <li>Parents informed that as the shielding advice for all adults and children was paused on 1 August 2020, even the small number of pupils who remain on the shielded patient list can also return to school, as can those who have family members who were shielding</li> <li>If rates of the disease rise in local areas (children (or family members) from that area may be advised to shield.</li> <li>If a pupil is unable to attend school because they are complying with clinical or public health advice e.g. self isolation or family isolation, they should have access to remote education.</li> </ul>
29.8.20	9	<ul style="list-style-type: none"> <li>Parents to be informed that primary school children will not need to wear face covering.</li> <li>Where social distancing is not possible in areas outside of classrooms between members of staff or visitors, staff and visitors can wear face coverings in these circumstances.</li> </ul>
29.8.20	1.12	<ul style="list-style-type: none"> <li>Identify pupils who are reluctant or anxious about returning or who are at risk of disengagement and develop plans for re-engaging them.</li> </ul>

		<ul style="list-style-type: none"> <li>• Use the additional catch-up funding schools as well as existing pastoral and support services, attendance staff and resources and schools' pupil premium funding to put measures in place for those families who will need additional support to secure pupils' regular attendance.</li> <li>• Work closely with other professionals as appropriate to support the return to school, including continuing to notify the child's social worker, if they have one, of non-attendance.</li> </ul>
29.8.20	2.6	<ul style="list-style-type: none"> <li>• All first aiders to ensure they have read the Health and Safety Executive published guidance on <a href="#">first aid</a> during coronavirus (COVID-19).</li> <li>• Ensure staff are clear that treating any casualty properly should be the first concern. Where it is necessary for first aid provision to be administered in close proximity, those administering it should pay particular attention to sanitation measures immediately afterwards including washing hands.</li> </ul>
29.8.20	3.9	<ul style="list-style-type: none"> <li>• Reception staff to have discussions with all visitors to the school (contractors, parents, supply teachers, peripatetic teachers, visitors) about the school's control measures. Site guidance on physical distancing and hygiene is explained to all visitors on or before arrival.</li> </ul>
29.8.20	9	<ul style="list-style-type: none"> <li>• Peripatetic teachers share their own risk assessments with the school.</li> <li>• Peripatetic teachers must maintain distancing requirements with each group they teach, where appropriate.</li> <li>• Peripatetic teachers must avoid situations where distancing requirements are broken; for an example demonstrating partnering work in dancing.</li> <li>• Peripatetic teachers must make effort to reduce the number of groups taught and locations worked in, to reduce the number of contacts made.</li> <li>• Ensure peripatetic teachers understand that they are expected to comply with the school's arrangements for managing and minimising risk, including taking particular care to maintain distance from other staff and pupils.</li> <li>• Music lessons to be timetabled whereby peripatetic teachers are given an allocated space and chair. Pupils are collected by the teacher and escorted to the allocated space (whilst maintaining social distancing).</li> <li>• Wind and brass instruments and singing lessons can be undertaken by considering and adopting the cumulative risk mitigation measures so that risk is reduced.</li> <li>• Space should be cleaned thoroughly between each lesson.</li> <li>• A record should be kept of all visits.</li> </ul>
29.8.20	9	<ul style="list-style-type: none"> <li>• Staff are aware that although singing and playing wind and brass instruments do not currently appear to represent a significantly higher risk than routine speaking and breathing at the same volume, there is now some evidence that additional risk can build from aerosol transmission with volume and with the combined numbers of individuals within a confined space. This is particularly evident for singing and shouting, but with appropriate safety mitigation and consideration, singing, wind and brass teaching can still take place.</li> <li>• Staff should ensure that when teaching music, dance and drama the pupils and staff should observe social distancing where possible. This may limit group activity in these subjects in terms of numbers in each group.</li> <li>• Physical correction by teachers and contact between pupils in dance and drama should be avoided.</li> <li>• Staff should keep background or accompanying music to levels which do not encourage teachers or other performers to raise their voices unduly. If possible, staff should use microphones to reduce the need for shouting or prolonged periods of loud speaking or singing. If possible, do not share microphones</li> <li>• If planning an indoor or outdoor face-to-face performance in front of a live audience, staff should follow the latest advice in the DCMS <a href="#">performing arts</a> guidance, implementing events in the lowest risk order as described. If planning an outdoor performance staff should also give particular consideration to the guidance on delivering <a href="#">outdoor events</a>.</li> <li>• Playing instruments and singing in groups should take place outdoors wherever possible. If indoors, teachers should consider limiting the numbers in relation to the space.</li> <li>• If playing musical instruments and singing in groups indoors, staff should ensure that a room is used with as much space as possible, for example, larger rooms and rooms with high ceilings. Numbers should be limited to account for ventilation of the space and the ability to social distance.</li> <li>• Singing, wind and brass playing should not take place in larger groups such as choirs and ensembles, or assemblies unless significant space, natural airflow (at least 10l/s/person for all present, including audiences) and strict social distancing and mitigation can be maintained.</li> </ul>

		<ul style="list-style-type: none"> <li>• In the smaller groups where these activities can take place, staff should ensure that strict social distancing between each singer and player, and between singers and players, and any other people such as conductors, other musicians, or accompanists is maintained. If the activity is face-to-face and without mitigating actions, 2 metres is appropriate.</li> <li>• Pupils should be positioned back-to-back or side-to-side when playing or singing (rather than face-to-face) whenever possible. Wind and brass players should be positioned so that the air from their instrument does not blow into another player.</li> <li>• Staff should ensure pupils use microphones where possible or encourage singing quietly.</li> <li>• Staff should ensure that pupils wash their hands before and after handling equipment, especially if being used by more than one person.</li> <li>• Staff to avoid the sharing of equipment wherever possible. They should place name labels on equipment to help identify the designated user, for example, percussionists' own sticks and mallets.</li> <li>• Staff should ensure that if instruments and equipment have to be shared they should be disinfected regularly (including any packing cases, handles, props, chairs, microphones and music stands) and always between users.</li> <li>• Staff should ensure that instruments should be cleaned by the pupils playing them, where possible.</li> <li>• Staff to limit handling of music scores, parts and scripts to the individual using them.</li> <li>• Staff should ensure that pick up and drop off collection points should be created where possible, rather than passing equipment such as props, scripts, scores and microphones hand-to-hand.</li> </ul>
29.8.20	9	<ul style="list-style-type: none"> <li>• Only provide team sports on the list available at <a href="#">return to recreational team sport framework</a>.</li> </ul>
14.9.20	9	<ul style="list-style-type: none"> <li>• Fire doors can be kept open in areas that are occupied.</li> </ul>
14.9.20	9	<ul style="list-style-type: none"> <li>• Parents to sign their child to the breakfast and afterschool club for the same set days for the whole half term.</li> <li>• Children will be in year group bubbles to reduce the number of contacts between children and staff.</li> <li>• Year groups to use assigned space. This should be cleaned each day.</li> <li>• Children to use assigned year group toilets.</li> <li>• Staff to be scheduled to work in the same year group they usually work in (if work at GP in the day) and to work in less year groups as possible.</li> <li>• Ideally, adults should maintain 2 metre distance from each other, and from children. This is not always possible, particularly when working with younger children, but staff should do this when possible. In particular, they will avoid close face to face contact and minimise time spent within 1 metre of anyone.</li> <li>• Staff working in more than one year group to ensure they socially distance from the children.</li> <li>• One way system for parents to adhere to when dropping/picking up their child to school. Parents shouldn't enter the school building.</li> <li>• Resources to be allocated to each year group bubble and will be cleaned meticulously or rotated to allow them to be left unused and out of reach for a period of 48 hours (72 hours for plastics) between use by different bubbles</li> </ul>
14.9.20	9	<ul style="list-style-type: none"> <li>• Staff are reminded not to car share</li> </ul>
17.9.20	9	<ul style="list-style-type: none"> <li>• Any shared toys, play equipment or materials that cannot be cleaned or disinfected should not be used. This includes sand, water, mud and playdough.</li> </ul>
17.9.20	2.1	<ul style="list-style-type: none"> <li>• Where a test has been taken because a member of staff or a pupil is symptomatic, they should inform the school immediately of the results of the test.</li> <li>• If the result is negative then ask for evidence of this. If the family do not wish to share this, then only accept the child back in school after the full isolation period of 10 days, and the household members on site after 10 days. Once the 10 day period of self-isolation has been completed do not request evidence of negative test results.</li> </ul> <p><b>2. Where recommended use of face coverings in schools</b></p> <ul style="list-style-type: none"> <li>• Where social distancing is not possible in areas outside of classrooms between members of staff or visitors, staff and visitors can wear a face covering in these circumstances.</li> <li>• Face coverings is not necessary in the classroom even where social distancing is not possible. Face coverings would have a negative impact on teaching and their use in the classroom should be avoided.</li> </ul> <p><b>10. Contain any outbreak by following local health protection team advice</b></p>

		<ul style="list-style-type: none"> <li>Advice provided by the local health protection team is acted on immediately.</li> <li>Good working relationships are established and maintained enabling rapid communication with local authorities and local Public Health England.</li> </ul>
19.10.20	9	<ul style="list-style-type: none"> <li>Any shared toys (including those with intricate parts), play equipment or materials that cannot be cleaned or disinfected should not be used. This includes soft toys.</li> <li>Sand, water, mud and playdough can be used if additional measures to reduce the risk of transmission are put into place (see below).</li> </ul>
19.10.20	9	<p>Use of sand, water, mud and play dough</p> <ul style="list-style-type: none"> <li>Children should wash their hands before and after use.</li> <li>Children should be reminded to not put their hands in their mouth whilst playing.</li> <li>Tools used should be washed regularly.</li> <li>Play dough should be separated out and used by a small group of children and thrown away at the end of each day.</li> </ul>
19.10.20	9	<p>Holiday club</p> <ul style="list-style-type: none"> <li>Children to be in bubbles of no more than 15.</li> <li>Siblings to be in in the same bubble.</li> <li>Children to not mix across bubbles.</li> <li>Staff to be allocated to specific bubbles.</li> <li>Children to use allocated cubicles according to their bubble. They will be sent to the toilet one at a time to ensure that no bubbles are mixing.</li> <li>Trained pediatric first aider to be on site at all times.</li> </ul>
24.10.20	1.12	<ul style="list-style-type: none"> <li>When a vulnerable child is asked to self-isolate, the social worker (if they have one should be informed. School leaders should then agree with the social worker the best way to maintain contact and offer support to the vulnerable child or young person.</li> <li>Procedures to be in place check if a vulnerable child is able to access remote education support, to support them to access it (as far as possible) and to regularly check if they are doing so.</li> </ul>
24.10.20	2.1	<ul style="list-style-type: none"> <li>Parents are strongly encouraged to wear face coverings at drop off and pick up.</li> <li>Staff are given visors to wear where social distancing is not possible in areas outside the classroom, staff are encouraged to wear this.</li> <li>Staff, parents and pupils to be reminded of how to wear properly including scrupulous hand hygiene and following guidance on <a href="#">how to put PPE on and take it off safely</a> in order to reduce self-contamination.</li> <li>Staff, parents and pupils to be reminded how to dispose of face coverings in a hygienic way.</li> </ul>
24.10.20	2.1	<p><b>8. Always keeping occupied spaced well ventilated.</b></p> <ul style="list-style-type: none"> <li>Well ventilated and a comfortable teaching environment is maintained.</li> <li>mechanical ventilation systems – these should be adjusted to increase the ventilation rate wherever possible, and checked to confirm that normal operation meets current guidance (if possible, systems should be adjusted to full fresh air or, if not, then systems should be operated as normal as long as they are within a single room and supplemented by an outdoor air supply)</li> <li>natural ventilation – opening windows (in cooler weather windows should be opened just enough to provide constant background ventilation, and opened more fully during breaks to purge the air in the space). Opening internal doors can also assist with creating a throughput of air</li> <li>natural ventilation – if necessary external opening doors may also be used (as long as they are not fire doors and where safe to do so)</li> </ul>
24.10.20	4.3	<ul style="list-style-type: none"> <li>If risks are identified during the pregnancy, in the first 6 months after birth or while the employee is still breastfeeding, the employer must take appropriate, sensible action to reduce, remove or control them.</li> </ul>
24.10.20	9	<ul style="list-style-type: none"> <li>Staff to be aware that these controls measures regarding signing relates to organised group activity, not to spontaneous singing, dance and role-play that young children may naturally do, and should be encouraged to do, by early years practitioners.</li> </ul>
24.10.20	9	<ul style="list-style-type: none"> <li>Where possible pupils with EHCPs to receive consistent support from the same staff member.</li> </ul>

		<ul style="list-style-type: none"> <li>Where it is more difficult to provide support to pupils with a EHCP (due to self isolation) decisions on how provision can be delivered should be informed by relevant considerations including, for example, the types of services that the pupil can access remotely, for example, online teaching and remote sessions with different types of therapists. These decisions should be considered on a case by case basis, avoiding a one size fits all approach. This should be considered in the pupils risk assessment.</li> </ul>
24.10.20	9	<p>Home visits</p> <ul style="list-style-type: none"> <li>Staff to make professional judgements of risk in each case and decide what form of contact they need.</li> <li>If households report no coronavirus (COVID-19) symptoms, no PPE is required, but a distance of 2 metres should be maintained where possible. If this is not possible, you should undertake a <a href="#">risk assessment</a>.</li> <li>Good basic hygiene should be followed, such as handwashing or use of sanitiser before and after the visit, and not touching your face during the visit.</li> <li>If households are reporting coronavirus (COVID-19) symptoms, PPE should be worn if a distance of 2 metres cannot be maintained. Anyone displaying symptoms should be encouraged to <a href="#">book a coronavirus (COVID-19) test</a>.</li> <li>Extra care should be taken when visiting a child or young person who is extremely clinically vulnerable and at very high risk of severe illness from coronavirus (COVID-19) due to an underlying health condition. For more information, read the <a href="#">guidance on shielding and protecting people who are clinically extremely vulnerable from COVID-19</a>.</li> <li>If it is not possible to find out whether any member of the household is suffering from symptoms of coronavirus (COVID-19) before face to face contact, steps should be taken where practical to mitigate risk. These steps include but are not restricted to: <ul style="list-style-type: none"> <li>knocking on the front door or ringing the doorbell and then stepping back to a distance of 2 metres in adherence to social distancing guidelines</li> <li>taking PPE as a precautionary measures</li> </ul> </li> </ul>
24.10.20	9	<ul style="list-style-type: none"> <li>If non-symptomatic children present behaviours which may increase the risk of droplet transmission (such as biting, licking, kissing or spitting) or require care that cannot be provided without close hands-on contact, they should continue to receive care in the same way, including any existing routine use of PPE.</li> <li>Staff should review and update existing risk assessments.</li> <li>In these circumstances, to reduce the risk of coronavirus (COVID-19) transmission, no additional PPE is necessary.</li> <li>Additional space and frequent cleaning of surfaces, objects and toys will be required.</li> <li>Cleaning arrangements should be increased, with a specific focus on surfaces which are touched a lot.</li> </ul>
24.10.20	9	<ul style="list-style-type: none"> <li>Contingency plans in place for individuals or groups of self-isolating pupils and in the event of tier 4 restrictions (where primary schools will be open full time to priority groups only) for remote education.</li> <li>Children to be offered immediate remote education in these circumstances.</li> <li>Remote education policy in place to set the expectation of remote education in line with the government guidelines.</li> <li>ELT Be Connected project in place to provide chromebooks for all pupils in year 1 upwards</li> <li>Allocated devices from government used for PP pupils</li> </ul>
24.10.20	9	<ul style="list-style-type: none"> <li>Children to be allowed to wear additional, suitable indoor items of clothing during the winter period in addition to the school's current uniform.</li> </ul>
5.11.20	1.3	<ul style="list-style-type: none"> <li>In line with the new national restrictions from 5 November: Those individuals who are clinically extremely vulnerable are advised to work from home and not to go into work. Update risk assessment accordingly.</li> <li>In line with the new national restrictions from 5 November: All other staff should continue to attend work, including those living in a household with someone who is clinically extremely vulnerable. (Update RA of those who are clinically vulnerable to confirm this).</li> </ul>
30.11.20	9	<ul style="list-style-type: none"> <li>Where pupils who are self-isolating and are within our definition of vulnerable, ensure the school put systems in place to keep in contact with them, offer pastoral support, and check they are able to access education support.</li> </ul>
30.11.20	9	<ul style="list-style-type: none"> <li>Under local restriction tier 3: very high alert, discuss flexibilities that support clinically extremely vulnerable staff, such as staggered start times to reduce travel during rush hour.</li> </ul>

30.11.20	9	<ul style="list-style-type: none"> <li>Ensure that educational visits are planned and carried out safely and in line with relevant national and local restriction tier guidance protective measures.</li> </ul>
30.11.20	9	<ul style="list-style-type: none"> <li>In line with the government advice attendance by parents will be restricted for indoor and outdoor face to face performances. The school to host audiences using alternative methods, such as through recording performances.</li> </ul>
29.12.20	1.16	<ul style="list-style-type: none"> <li>Appropriate action is taken once advised by the local health protection team – this may mean that year group bubbles and some staff who have been in close contact with the person concerned may have to self-isolate for 10 days.</li> </ul>
29.12.20	2.1	<ul style="list-style-type: none"> <li>Anyone with symptoms must remain at home and self-isolate for 10 days from testing positive. Anyone in their household needs to self-isolate for 10 days (including siblings).</li> </ul>
29.12.20	2.1	<ul style="list-style-type: none"> <li>If the result is negative then ask for evidence of this. If the family do not wish to share this, then only accept the child back in school after the full isolation period of 10 days, and the household members on site after 10 days. Once the 10 day period of self-isolation has been completed do not request evidence of negative test results.</li> </ul>
29.12.20	9	<ul style="list-style-type: none"> <li>Ensure that staff are aware of the requirement for people returning from some countries to quarantine for 10 days on their return.</li> </ul>
3.1.21	9	<p>No further measures in place to reduce the risk of the virus in the event of restrictions to primary schools whereby only critical workers and vulnerable children are in school:</p> <ul style="list-style-type: none"> <li>Reduce the number of staff on site. Staff to work from home if able to.</li> <li>With increased numbers of staff on site, staff to ensure that they have enhanced social distancing between each other</li> <li>Bubbles to be kept to a minimum size as possible to reduce the number of contacts</li> <li>Due to the reduced numbers of children on site and children in bubbles, staff to ensure they have enhanced social distancing between themselves and each other</li> <li>Staff to remind the children about staying in allocated seats in classrooms and maintaining a distance between each other where possible. Children to be reminded about all other measures to reduce the risk of transmission.</li> <li>Where sports coaches take classes for PE, they are to ensure that they are over 2 metres from the children (in coned area on play ground or on the stage when inside the hall). All PE lessons to be carried out with an additional adult to ensure that the sports coaches are not having to administer first aid or have to make close contact with any child. Outside should be prioritised. Halls to be used in wet weather (but should be well ventilated)</li> </ul>
3.1.21	9	<ul style="list-style-type: none"> <li>Collection slots to be allocated to parents who are invited to collect chromebooks or hampers</li> <li>Location of collection points to be considered carefully</li> <li>Parents to be reminded about socially distancing.</li> </ul>
18.1.21	1.15	<ul style="list-style-type: none"> <li>All staff, pupils and others may be at greater risk of contracting the virus as with current new variant is also prevalent as well as the original strain. At this time the Government advise that the new variant does not appear to be more harmful</li> <li>All mitigation measures listed throughout the risk assessment are still relevant. The increased chance of infection highlights the importance of adherence to control measures. Where practicable consider reviewing controls and monitoring/checks on behaviours and controls taking place.</li> <li>Advice and guidance is being constantly updated and particular attention should be given to guidance, should any be produced, where it refers to any required measures relating to the new variant.</li> </ul>
18.1.21	9	<ul style="list-style-type: none"> <li>Musculoskeletal disorders as a result of using DSE at home for a long period of time</li> <li>Refer to the Schools Hub advice sheets; "DSE Self Assessment – COVID-19 – Sheet No. 4 and Working from Home for Schools – COVID-19 CBT Advice Sheet".</li> <li>Follow guidance on display screen equipment in the HSE Protect homeworkers page</li> <li><a href="#">HSE - Protect home workers - Coronavirus (COVID-19)</a></li> <li>There is no increased risk for people working at home temporarily but if this arrangement becomes long term the risks should be assessed</li> <li>For all people working at home using display screen equipment (DSE) put in place information and training on how to protect themselves, e.g. take regular breaks, stretching exercises, set the equipment up properly</li> </ul>

		<ul style="list-style-type: none"> <li>For people working at home longer term complete a DSE assessment with them and identify what equipment is needed to allow them to work safely at home</li> <li>Schedule or build in breaks of minimum of 5 minutes every hour for pupils studying- parents informed via the loan agreement.</li> <li>Staff to consider breaks from this work. 5 minutes every hour is better than 15 minutes every 2 hours. Consideration to how this can be scheduled in could include actual separate breaks or in lesson time outs.</li> </ul>
18.1.21	4.3	<ul style="list-style-type: none"> <li>Carry out Individual COVID-19 Risk Assessment for those at increased risk version 5a and for New and Expectant Mothers Briefing version 6a- updated advice.</li> <li>They are <b>defined as clinically extremely vulnerable at 28 weeks / third trimester)</b> – and/are advised to work from home and not to go into work.</li> <li>Expectant mothers Clinically Vulnerable can return to work as long as there is a COVID-19 risk assessment, New and Expectant Mothers Risk Assessment, discussions have taken place and control measures in place for the school.</li> <li>Consultation on the general COVID-19 risk assessments for the school and its arrangements should also take place.</li> </ul>
18.1.21	1.3	<ul style="list-style-type: none"> <li>clinically extremely vulnerable should follow <a href="#">resumed shielding guidance</a> and should not attend work, school, college or university. limit the time you spend outside the home. <a href="https://www.gov.uk/guidance/national-lockdown-stay-at-home">https://www.gov.uk/guidance/national-lockdown-stay-at-home</a></li> </ul>
18.1.21	4.1	<ul style="list-style-type: none"> <li>Note: Shielding advice is currently in place and children who are clinically extremely vulnerable are advised not to attend education or childcare.</li> <li>If a doctor has confirmed that a child is still <a href="#">clinically extremely vulnerable</a>, the advice is that they should not attend nursery, school or college during the period of national restrictions.
